June 1 and June 2, 2019, will be transition days and all Spartan Federal accounts will be fully converted to South Carolina Federal on June 3, 2019. Below is information regarding the conversion of your current Spartan Federal Consumer Loan Account(s). Consumer Loans include the following: Personal, Boat, Motorcycles, Overdraft Line of Credit and Vehicles.

Your loan(s) with South Carolina Federal **will have the same rate, terms, conditions, suffix and payment due date** as your current Spartan Federal loan(s). South Carolina Federal offers several simple ways to make timely payments to your loan.

Payment options include:

- Online Banking – set up payments for your loan in our convenient online banking system. You can also set up recurring payments to ensure your South Carolina Federal loan payments are made on time each month.
- Mobile Apps – once you are setup in Online Banking, you can schedule a payment in seconds using our mobile apps for iPhone and Android.
- Financial Center – stop by any convenient financial center location to make a payment.
- Phone – simply call 864-406-8300 and transfer funds for South Carolina Federal payments by phone.
