**IMPORTANT INFORMATION REGARDING YOUR
SPARTAN FEDERAL CREDIT UNION MEMBERSHIP**

Dear Member,

As you may already be aware, South Carolina Federal Credit Union is pleased to be acquiring Spartan Federal Credit Union, via a merger. As of June 1, 2019, Spartan Federal Credit Union members will become South Carolina Federal Credit Union members. This is the result of a January 24, 2019 member vote to approve the merger and we are thrilled to welcome our newest members to the South Carolina Federal family. On May 31, 2019, Spartan Federal account data will be transferred to South Carolina Federal. June 1 and June 2 will be transitional days, and all account information will be fully integrated to South Carolina Federal by June 3. Our goal is to make this a simple transition for you.

The Spartan Federal ATM will be removed on May 20. A new South Carolina Federal ATM will be installed on May 21. As of May 21, Spartan Federal members will have fee-free access to withdrawal options with Spartan Federal debit cards at all South Carolina Federal ATMs. As of June 2, Spartan Federal members will have fee-free access with South Carolina Federal debit cards at all South Carolina Federal ATMs and surcharge-free access to 50,000 ATMs worldwide via the Allpoint network.

Spartan Federal has been associated with two ATM networks: Dolphin Debit and CO-OP. Upon activation of your new South Carolina Federal debit card, you will have fee-free access to Dolphin Debit ATMs. Details on the use CO-OP Network ATMs will be provided in the future.

With a few exceptions, all Spartan Federal accounts will transfer to corresponding South Carolina Federal accounts. In the coming weeks, you will receive account specific information with important details and key dates, explaining exactly what to expect through the transition period.
